# Chairman's Letter



Greetings to all friends and supporters of the Environmental Learning Center (ELC)! Thank you for helping us celebrate a momentous year. Founded in 1988 by a group of environmentally conscious pioneers in the community, the ELC celebrated its 25th anniversary in 2013. In recognition of this milestone, the community was bustling from points north and south with 15 lagoon-themed events from January through April.

More than 5,500 people of all ages participated in a wide range of activities to uncover the many wonders of the Indian River Lagoon. They also discovered how the ELC has served the community through interactive educational experiences for the past two-and-a-half decades. Many of the events were free of charge, thanks to sponsors and supporters who underwrote some of the costs or hosted events up and down the waterway.

We believe that when admiration and respect for nature is established early, the next generation will grow up to be ecologically conscientious adults – prepared to make positive choices regarding the natural systems that sustain us all. Since inception, we have taught close to 400,000 people how to be better stewards of the Lagoon and surrounding environments and have indirectly impacted 1,000,000 people.

The ELC is for people of all ages, who recognize that the Indian River Lagoon and our surrounding environments are fundamentally important to the Treasure Coast quality of life. We are THE environmental

education organization dedicated to increasing awareness of both the value and vulnerability of our fragile Lagoon environment by changing behaviors and inspiring better stewardship through education. Our combination of proven educational skills, superb environmental knowledge, and one-of-a-kind campus on the Lagoon makes the ELC uniquely qualified to provide hands-on learning experiences that truly make a difference in people's behavior. Our educators are superb at translating and interpreting the science to make it easily understandable for all segments of the community.

With the current crisis conditions in the Lagoon, our work has never been more important. Recently, 47,000 acres of seagrass habitat has died in the Lagoon adversely affecting fish, dolphins, manatees and birds. Therefore, your support of the ELC has never been more important.

With your participation in and support of the ELC, you can feel confident in your environmental stewardship and know that you are helping to protect and enhance the things you hold dear for future generations.



- Naturalist Sarah Rhodes-Ondi mentored 27 Junior Interpreters and Environmental Ambassadors who volunteered 628 hours to participate in stewardship activities such as growing plants to be used for shoreline restoration and cleaning up Lagoon islands
